

WILDCAT 5 PACK RULES

- Wildcat 5 Packs may be picked up at Seven Springs until the Lodge at Laurel Mountain is operational. During this time, the Season Pass Office hours are 9 a.m. - 5 p.m., daily. The office will be open 9 a.m. - 7 p.m., daily, once the slopes are open.
- YOU MUST HAVE PROPER IDENTIFICATION WITH YOU WHEN PICKING UP YOUR CARD.
- Wildcat 5 Packs will not be issued until all information provided on this application is verified by the Laurel Mountain Season Pass Office staff.
- For everyone's safety, all skiers and snowboarders must obey Your Responsibility Code and Laurel Mountain's area policies.
- Card is valid opening of season through the end of the 2016-2017 season or March 26, 2017.
- If your Wildcat 5 Pack is lost or stolen, notify the Season Pass Office immediately.
- Replacement allowed one time only, at our discretion, at a charge of \$15.
- Please protect your Wildcat 5 Pack as you would your cash or credit cards.

WILDCAT 5 PACK RELEASE AND WAIVER AGREEMENT

In consideration for a Wildcat 5 Pack for use of ski slopes, lifts, terrain areas, and other facilities related to downhill skiing/snow boarding issued daily by Seven Springs Mountain Resort, Inc., d/b/a Laurel Mountain, its owners, officers, employees, agents, representatives, parents, and affiliates (hereinafter, "Laurel Mountain"), I agree:

(1) that I understand that there is a risk of serious injury or death if I participate in skiing or snow boarding. It would be impractical to list all the risks. Some of the risks include, falls caused by bare spots, variations in surface and subsurface snow and ice conditions, variations in terrain and terrain area features (table tops, ramps, half-pipes, rails, etc.), bumps, moguls, stumps, rocks, other forms of forest growth and debris. Risks also include collisions with other persons, lift towers, poles, cables, snow making equipment, snowmobiles, grooming machines, fences, barriers, and other natural and man-made obstacles on and/or off of trails. Another risk is falls and collisions caused by the negligence of others, including Laurel Mountain. I acknowledge that it is my responsibility to follow "Your Responsibility Code", all rules regarding terrain park use, and all other instructions, rules and directions provided by Laurel Mountain, and to exercise caution and remain in control while participating.

(2) to accept all risks, whether specifically listed in paragraph (1) above or not, which arise out of or are related to the use of my Wildcat 5 Pack to ski or ride at Laurel Mountain.

(3) that my Wildcat 5 Pack may be suspended or revoked, without reimbursement to me, if I do not follow the rules, instructions and directions of Laurel Mountain.

(4) to waive my right to bring any claims against Laurel Mountain that arise out of or relate to my use of my Wildcat 5 Pack to ski or ride at Laurel Mountain, and to release Laurel Mountain from liability for any such claims. This waiver and release includes, but is not limited to, claims based upon allegations of negligence on the part of Laurel Mountain. I further agree that I will indemnify, hold harmless, and reimburse Laurel Mountain for all losses (including attorneys' fees and costs) from any claims brought by any persons or entities arising out of or relating to my use of my Wildcat 5 Pack to ski or ride at Laurel Mountain.

(5) that the terms of this Agreement shall be binding on my heirs, executors, administrators and assigns, and shall be governed by the laws of the Commonwealth of Pennsylvania. I agree that all disputes arising under this Agreement shall be litigated in the Court of Common Pleas of Somerset County, Pennsylvania.

(6) I grant Laurel Mountain permission to use photographic and/or video images of me for the purpose of marketing, publicizing and promoting the resort operations. I waive any right to be compensated for the use of my image and release Laurel Mountain from liability for any claims, where such claims arise out of or relate to Laurel Mountain's use of my image.
